NEW BUSINESS

A. ZONING BOOKS

Mr. Stevenson stated that he got pricing for new updated zoning books that would include a colored map. Oceana Graphics would charge \$306.64 for 20 books. The board agreed to wait and budget in cost for the next fiscal year.

The board discussed the renewal for property and casualty insurance through Burnham & Flower Insurance Group. They agreed to decline the Terrorism coverage and pay the Michigan Township Participating Plan Package at a cost of \$2,867.00.
