Minutes from the regular June meeting held Monday, June 13, 2016 were approved as read.

Treasurer reported \$241,127.71 in checking.

Moved by Dale Stevenson, supported by Gary Hilbert to have Ken Adams clear trees & brush along east side of North Weare Cemetery for a new driveway. Grading, leveling and placing crushed asphalt on driveway & old driveway. Approximately 540ft long by 8ft wide at a cost of \$4,450.00.
