Meeting was called to order at 7:30 p.m. by Dale Stevenson, Supervisor.

Minutes from the regular February meeting held Monday, February 8, 2016 were approved as read.

Treasurer reported \$237,408.07 in checking.

Moved by Gary Hilbert, supported by Linda Dykema to amend the 2015-2016 budget by moving \$1,222.20 out of Township Board, \$952.59 out of Supervisor, \$72.28 out of Elections, \$2,836.50 out of Clerk, \$1,381.74 out of Treasurer, \$987.09 out of Groundskeeper, \$500.00 out of Zoning Board of Appeals, and \$335.00 out of Recreation along with transferring \$40,140.44 out of the General Fund to cover our overages in Assessor, Board of Review, Town Hall, Cemetery, Fire, Zoning Administrator, Zoning Board, Trailer Park Taxes and Library totaling \$48,140.44. Also transferring \$66,661.73 out of road fund to cover our overage in roads.
