#### WEARE TOWNSHIP APPLICATION SCORING RUBRIC

PURSUANT TO THE WEARE TOWNSHIP MARIJUANA ESTABLISHMENTS LICENSING AND REGULATION ORDINANCE, LICENSES ISSUED WILL BE PROCESSED THROUGH A MERIT BASED REVIEW SCORING SYSTEM. THE WEARE TOWNSHIP PLANNING COMMISSION WILL RELY ON A WEIGHTED SCORING RUBRIC TO EVALUATE EACH APPLICANT. THE TOTAL POSSIBLE POINTS FOR AN INDIVIDUAL APPLICANT IS 52. ONCE SCORED, THE APPLICATIONS WILL BE RANKED FROM HIGHEST TO LOWEST. THE DECISION OF THE WEARE TOWNSHIP PLANNING COMMISSION WITH RESPECT TO SCORING SHALL BE FINAL AND NOT SUBJECT TO APPEAL OR REVIEW. THE TOWNSHIP BOARD RESERVES THE RIGHT TO GRANT OR DENY LICENSES REGARDLESS OF SCORING RANK.

Note: Applicants shall be required to meet and be in full compliance with all requirements for licensure as set forth in the Weare Township Marijuana Establishments and Regulation Ordinance prior to the issuance of a license.

Under MCL 333.27959(4), "the municipality shall decide among competing applications by a competitive process intended to select applicants who are best suited to operate in compliance with this act [the Michigan Regulation and Taxation of Marihuana Act, MCL 333.27951, et seq.] within the municipality."

Instructions: Each of the below-listed criteria will be reviewed separately, independent of any other criteria. EXAMPLE: Applicant with 7-years business experience will receive Yes -1 for "More than 2-years of experience" and Yes -2 for "More than 6-years of experience."
